- Oral History Committee** shall prepare and present to the Board of Trustees or the Executive Committee the Committee's proposed activities for the ensuing years. Before implementation of any of the proposed activities, the Board or the Executive Committee must approve the activity and the implementation thereof.
- Publications Committee** shall have supervision of all the publications issued in the name of the Society including; the newsletter, *Historia Juris*, annual magazine, *Florida Supreme Court Historical Review* and publication of *History of the Florida Supreme Court*.
- Special Gifts & Projects Committee** shall be vested with the responsibility of securing general and special purpose contributions of funds to the Society and coordinating special and ongoing events of the society and court when needed.
